

# Toastmasters International District 21 – 96 Joint Business Meeting Minutes

#### 1. CALL TO ORDER

Presiding Officer Gary Schmidt, DTM, Past International President called the meeting to order. He welcomed the members and guests to the joint District 96 and 21 Business Meeting.

#### 4. ALIGNMENT REPORT

Alignment Committee Co-Chair Sharookh Daroowala, DTM presented the previously posted new District 21 Alignment Report. The Alignment Committee was co-chaired with Karen Burgess, DTM, PDD, RA. He noted that 10 years ago District 21 was split into Districts 96 and 21, and they will be reunified as District 21 on July 1.

- Realignment Criteria: Efforts were made to evenly distribute stronger and weaker clubs and
  accommodate potential growth. The plan takes into account geography, club strength, meeting formats
  (in-person, hybrid, online), meetings days/times. Club type (community, corporate or advanced) and
  recent club losses or additions. Each area should have 4-6 (minimum 3) clubs.
- New Divisions: There will be 9 divisions of 4-5 areas each in the realignment: Division A (Victoria & South Vancouver Island), Division B (Vancouver Island), Division C (Sea to Sky, Sunshine Coast, North Shore & Vancouver), Division D (Vancouver), Division E (Vancouver, Coquitlam, Port Moody), Division F (Burnaby), Division G (Delta, Richmond, Surrey), Division H (Surrey and the Fraser Valley) and Division J (Northern, Kootenays, Okanagan).
- **Size of Divisions:** Most divisions will have 23-29 clubs. The divisions will have between 262 and 457 members.

On behalf of the Alignment Committee, Sharookh Daroowala moved that the D21 Alignment report for 2025-2026 be adopted as presented.

Gary Schmidt asked if there were any questions, suggestions or objections.

# **Informal Considerations**

- Louisa Davis said that City of the Arts has been renamed Presentation Artists. Since it is a hybrid club between Powell River and Port Moody that is focused on meeting in person in Powell River, she thinks it does not fit that well into D53, which is in Burnaby. She suggested that it be moved to the Sunshine Coast (C23) due to geographic proximity. There were no objections to the proposed change.
- Paul Rostagno asked with the letter "I" was skipped as a division letter. Karen Burgess said the letter "I" was skipped as it is difficult to identify as a division letter.

With no objections, the Realignent Report was approved with the change proposed by Louisa Davis. The results of the Realignment Report will be submitted to TI WHQ by July 15, 2025.

#### 6. TRANSITION COMMITTEE REPORT

Transition Committee Co-Chairs Immediate Past District 96 Director Paul Rostagno, DTM gave the following update on the transition of Districts 21 and 96 to one unified district, District 21. His Co-Chair was Past District 21 Director Phyllis Nielsen.

- **Districts 21 & 96 Merge:** The merging of districts is a mandate from TI Board of Directors due to their assessment that there are too many districts and too many small districts; districts must have at least 130 clubs. He displayed a visual showing how Mary Morrison, DTM, PID has been spearheading the Region 1 Realignment, which covers districts in BC, the Yukon, Alaska, and Washington state. The outcome is that Region 1 will be divided into two districts: one in Canada and one in the US. The transition was divided into three buckets: the District Leadership Committee (chaired by PDD 96 Carole Murphy, DTM), the District Realignment Committee (chaired by Karen Burgess, PDD 21, RA), and the District Transition Committee (co-chaired by Paul Rostagno and PDD 21 Phyllis Nielsen, DTM). There will be a Joint D21 and D96 Business Meeting on May 27 facilitated by Gary Schmidt, PIP.

They also involve identifying district leaders, joint communications, year-end financials, recognitions, district and club officer training, incentives, and 2025/2026 district contests.
